What experience/perspective will you bring to the committee?

As a trained scientist and a long-time high school science teacher, I want to ensure that good science is applied to decisions by CEA. As a Sierra Club member working for more than 5 years to bring Community Choice Energy to Carlsbad, I want CEA community programs to benefit local residents and be aggressive in mitigating climate change while making sure the energy procurement process does no harm to our natural open space. Our Sierra Club team reached out to residents and businesses to educate them about the benefits of CCE during our lobbying efforts; I hope to continue

that effort. I have followed, and sometimes commented upon, the actions the CEA board have taken to date. Lastly, I am one of a handful of our Sierra Club team monitoring Carlsbad's Climate Action Plan to ensure it has strong, measureable outcomes. We try to ensure transparency in how the staff determines goals are met by communicating with staff regularly.

Describe any relevant background in or expertise related to one or more of the following fields: electricity, community outreach or engagement, or policy advocacy.

I had the pleasure of first informing Board member Schumacher about the benefits of Community Choice Energy more than 5 years ago. Along with the rest of my local Sierra Club team we lobbied the city council to create a CCE provider. We spent many hours outside city libraries to educate the public about what CCE is and its benefits. At a number of house parties we educated neighbors on CCE. We presented a petition with over 600 resident signatures to the council in support of CCE. We then set up a campaign to solicit support from business owners and got 75 signees from Carlsbad businesses. We talked to representatives at both Viasat and ThermoFisher about CCE as well. Given the lack of knowledge about CCE by the general public, I believe we need an aggressive outreach program that goes beyond what we've seen so far and think the CAC can help in that effort. My other community outreach programs are with Preserve Calavera - public education events and running a CA Naturalist program.

Do you have any interests or associations that might present a conflict of interest? If yes, please explain:

None that I know of.

What do you hope to accomplish as a member of the Clean Energy Alliance Community Advisory Committee?

I'd like to see CEA with input from the CAC create some strong programs to mitigate climate change by offering incentives to customers for energy efficiency items like heat-pump water heaters, especially for low income households and renters. Rebates for new and used EVs could encourage more people across the economy to invest in clean transportation. Such programs can help foster social equity. In addition, as a benefit of CCE, we should create community solar projects. Other CCEs in the state have many programs we can draw from. I would also urge that any local power generation projects be mindful of the impact on our natural environment.

PROFESSIONAL EXPERIENCE

Over the course of my thirty seven year professional career I have developed a personal therapeutic style which draws heavily from an eclectic variety of therapeutic modalities. My early training in the seventies and eighties was forged by a strong foundation in psycho dynamic approach to assessment and treatment and is steeped in the reflective styles of C. Rogers, MD., and the interpretive associations of F. Perls, MD.. My understanding of psychotherapy is informed by the developmental models formulated by M. Mahler. I use many of the psycho-drama techniques pioneered by J. Moreno, MD. In drawing from more contemporary fields, I utilize cognitive behavioral therapy, motivational interviewing, and exposure therapy protocols.

I am very sensitive to cultural, behavioral, ethnic, and religious diversity as a hallmark of my approach to working with patients in a collaborative and nonjudgemental manner. I am continuously honored by the number of patient referrals I receive from past clients, as well as clients returning for followup care, often many years following initial treatment.

I work with individuals, couples, families and adolescents. I treat most forms of anxiety, depression, separation issues, relationship issues, (including premarital counseling), post traumatic stress disorder, (military and other first responders), military family separation and reintegration issues, alcohol and chronic substance and thrill seeking behaviors as well as other maladaptive behaviors.
