Item 4: Amendment to JPA re: Chair/Vice Chair Terms

- July 29, 2021 CEA Board directed staff to return with an amendment to JPA changing Chair & Vice Chair terms from Fiscal Year to Calendar Year
- JPA provides direction on process to amend JPA
 - Provide member agencies 30-days advance written notice
 - Written notice provided no concerns expressed
 - Requires affirmative vote of 2/3 Board Directors
- Current terms would expire June 30, with new terms beginning July 1 June 30.

Item 5: Assignment of Shell Energy Long-Term Renewable Energy Contract

- Recommendation:
 - Approve assignment of Shell Energy North America Portfolio Category 1 Long-Term Renewable Energy Transaction Confirmation from Solana Energy Alliance to Clean Energy Alliance for delivery period 2022-2034 for an amount not to exceed \$1,131,000 and authorize the Interim Chief Executive Officer to execute all documents.



Item 5: Assignment of Shell Energy Long-Term Renewable Energy Contract

- Solana Beach entered into the agreement with Shell to satisfy the long-term renewable energy requirements for then Solana Energy Alliance customers.
- Customers have now transferred to CEA, this assignment ensures the long-term renewable requirements continue to be met.
- CEA can begin taking delivery of the energy produced by existing renewable generating facilities in 2022
- Sourced from solar and wind facilities
- Pricing is within current market rate
