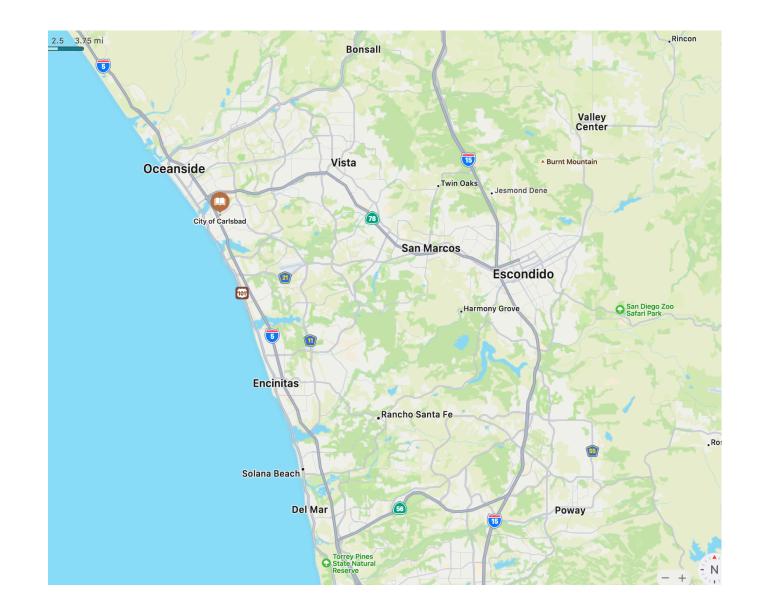

- Recommendation:
 - Approve fiscal year 2021/2022 midyear adjustment
 - Increase Revenue \$9,709,755
 - Increase Expenditures \$9,507,525



Item 5: Midyear Budget Adjustment

- Revenue Adjustment
 - Energy Sales \$3,709,755
 - Higher than anticipated energy sales
 - Revenue from rate adjustment
 - Line of Credit increase \$6.0M
 - Board Approval January 13
