ITEM 1: Consider Approval of Resolution No. 2023-006 Establishing Salary Schedule

RECOMMENDATION

Approve Resolution No. 2023-006 Establishing Salary Schedule.

BACKGROUND AND DISCUSSION

The Clean Energy Alliance has approved funding and positions in its Fiscal Year 2023/24 Budget. These positions include:

Board Secretary/Administrative Assistant Key Accounts/Programs Manager Regulatory Analyst Power Procurement Manager

Southern California Community Choice Aggregation programs were surveyed to determine the salary schedules for these positions. The agencies surveyed included San Diego Community Power, Orange County Power Authority and Clean Power Alliance. These agencies were selected due to Clean Energy Alliance competing with these agencies in recruiting for the best candidates. Based on the salary surveys staff recommends the following salary ranges be approved in the salary schedule:

Board Secretary/Administrative Assistant	\$98,000 - \$164,000
Key Accounts/Programs Manager	\$98,000 - \$164,000
Regulatory Analyst	\$98,000 - \$164,000
Power Procurement Manager	\$137,000 - \$244,000
