#### Item 10: CAC Actions

- Community Advisory Committee Structure
  - Current Structure
    - 2 appointees from each member agency + 1 chair (Board Alternate)
  - Board requested following questions come back January 2024
    - Should the make-up of the CAC change from 15 active?
    - Should the Chair of CAC be from a different member agency than Chair of the Board



#### Item 10 - CAC Actions

- CAC Input to Change in # of CAC Members
  - Prefer to keep current structure
  - Postpone any change to CAC until CEA has been up and running longer and more experience in all communities
  - Larger CAC facilitates effective Subcommittee structure
  - Reducing to 1 active CAC member from each community would result in ineffective outreach to the communities



#### Item 10 - CAC Actions

- Staff Input to Change in # of CAC Members
  - The current make-up worked well for coverage at events
  - CAC members are active and enthusiastic
  - No administrative issues related to the size
    - If one CAC member is unavailable for a meeting the City still has representation
    - Rare for all 15 members to be present at a meeting
  - Staff supports recommendation from CAC to maintain current structure.

  - The Board requested this question come back after this full year of all 7 members on CAC.
