## FY2023-2024 Revenue Shortfall

- Revenues (billing to Customers) are expected to be approximately 12% lower than the budgeted level:
  - Equal to \$28.2 million shortfall
  - Actual loads are approximately 3% lower than budgeted mostly due to "softer" use across the state.
    - Cooler-than-average Summer temps
  - Historical datasets provided by SDG&E for the expansion communities (Encinitas/San Marcos and Oceanside/Vista) appear to have been overstated which led us to project higher usage than we have seen
    - Current full-year FY2024 load forecast is approximately 12% lower than the original budget – in line with revenue shortfall

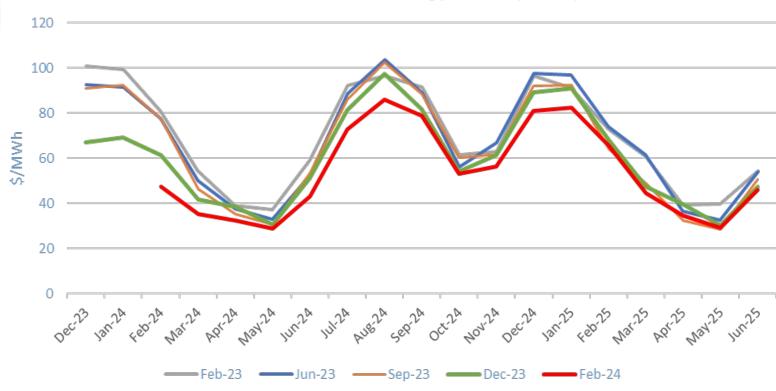
## **Energy Costs – deeper dive**

- With revenue lower than budget mostly due to lower load, we would have expected energy costs to also be lower.
- However,
  - Resource Adequacy prices are significantly higher
  - Renewable/GHG-Free Energy prices are significantly higher



## **CAISO Energy Prices**



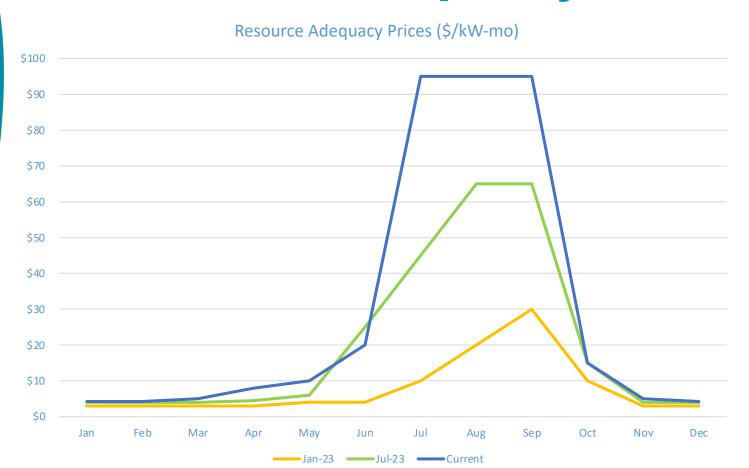


- CAISO forward energy prices for the next 12-month period (Bold RED line) have recently declined and are now 18% lower compared to one year ago
- Reductions are primarily the result of sharp declines in natural gas prices
- For conservatism, CEA has consistently been hedged well in advance which locked in prices at higher rates

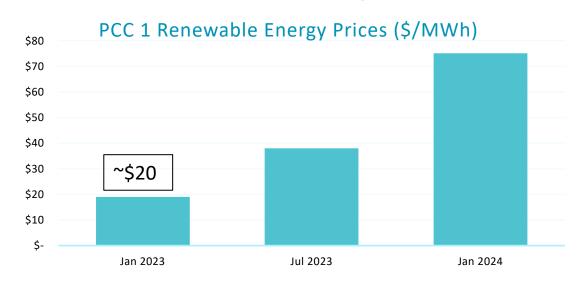
## Resource Adequacy Prices

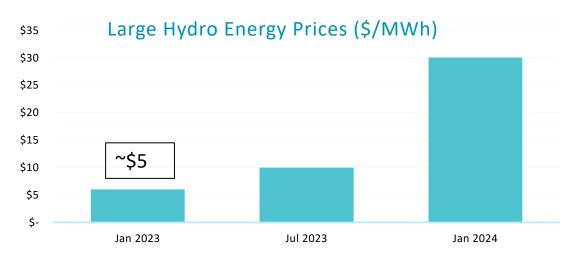


- 2025 RA markets remain extremely tight
- Sellers are reluctant to transact pending new slice of day framework implementation for 2025
- 2025 RA prices are projecting higher than the heights of 2024
- CEA has been mitigating some of the cost increases by paying penalties in high summer months
- Possible relief in 2026-27 as delayed storage projects reach commercial operation CLEAN ENERGY

## FY2023-2024 Expenses Below Budget – But not enough to make up for revenue shortfall

- Energy expenses expected to be \$8.2 million less than budget
- Other expenses expected to be \$4.2 million less than budget
- Interest expense/income expected to \$0.5 more than budget
- Net result is that Total Expenses are expected to be approximately \$12.0 million less than budget
  - Not enough to make up for the \$28.2 million revenue shortfall
