* This comparison illustrates the estimated electricity costs for a typical TOU-A commercial customer within the Clean Energy Alliance with an average monthly consumption of 1,056 kilowatt-hours (kWh). This is based on 12-months of billing history for all customers on a TOU-A rate plan and published rates as of February 1, 2025.

Generation Rate is the cost of generating and/or purchasing electricity to power your home or business. The generation rate varies based on your energy provider and the resources included in your energy provider's generation power source.

SDG&E Delivery Rate is SDG&E's charge to deliver electricity to your home or business. The electric delivery rate may vary depending on your rate and electricity use; however, it is charged equally to customers regardless of who provides your electric generation.

SDG&E PCIA & FF represents the **Power Charge Indifference Adjustment (PCIA)** and **Franchise Fee Equivalent Surcharge (FF)**. The PCIA is a charge to ensure that both SDG&E customers and those who have left SDG&E service to purchase electricity from other providers pay for the above market costs for electric generation resources that were procured by SDG&E on their behalf. "Above market" refers to expenditures for generation resources that cannot be fully recovered through sales of these resources at current market prices. The FF is a surcharge applied to electricity transported over SDG&E systems that are constructed in public streets and highways. SDG&E collects the surcharge from customers and remits them to the appropriate municipality. This surcharge is charged equally to customers regardless of who provides your electric generation. The PCIA and the SDG&E commodity portion of the FF are included within the generation rate of SDG&E's standard bundled service on a customer's bill.

**CEA receives a small portion of its renewable energy from an eligible SDG&E legacy wind resource under a state-approved allocation process. This is reported as retired unbundled renewable energy credits (RECs) amounting to 1%, which contributes to CEA's 50% renewable content.

*** Unspecified sources of power refers to electricity that is not traceable to a specific generating facility, such as electricity traded through open market transactions. Unspecified sources of power are typically a mix of all resource types, and may include renewable.
